This is in continuation to this office letter no. ADS/CON./1-19/2025 dated 11.05.2026 vide which result of Competitive Examination for direct recruitment to the cadre of Multi-tasking Staff (MTS) was declared and all the Divisional/Unit Heads were instructed to issue offer of appointment to the selected candidates and submit the refusal of candidate, if any, by 20.05.2026.

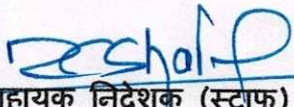

4. Allotment of Division/Unit to selected candidate has been made as per instruction contained in Directorate letter No. 17-08/2018-SPN-I dated 18.10.2023 followed by letter dated 31.10.2023. This allotment is also subject to change, if any discrepancy found in allotment later on.



5. The information relating to the name of candidate, his/ her roll number, category, and date of birth has been provided based on the data furnished by the concerned Division/Unit. In case, there is any mistake in the detail of candidate, the same may be intimated to this office for necessary action.
6. In case, if it is found subsequently that the selected candidate was not eligible for the examination/selection under the existing rules/instructions on the subject or for any other reasons or in case any mistake is found with regard to declaration of result of the candidate for any reason whatsoever, his/her name will be deleted from the list of successful candidates, as the case may be. This result is also subject to change in the merit list of successful candidates due to any unforeseen reason in accordance with the existing rules and instructions on the subject.
7. Before appointment, it should be ensured that no disciplinary/vigilance case is pending or punishment is current against the selected candidate. In case any vigilance/disciplinary case is pending against the official, he/she should not be relieved for posting and the case should be referred back to this office as per directions of Directorate issued from time to time.
8. Concerned Divisional/Unit Heads are instructed to take necessary action for joining of newly selected candidates as per extant provisions. The joining process should be completed on or before **10.08.2026** positively.
9. In case of unwillingness/refusal of candidate, the same may be submitted to this office by **10.08.2026** positively. If concerned Division/Unit especially where the candidate is presently working is failed to submit the refusal within stipulated time, it will be held responsible for that.
