I am directed to intimate that the Limited Departmental Competitive Examination (LDCE) among eligible Postman/Mail Guard/MTS for promotion to the cadre of Postal Assistant (CO/RO)/Postal Assistant (PO) / Sorting Assistant for the vacancy year 2026 (01.01.2026 to 31.12.2026) was held on 28.06.2026 (Sunday), followed by Data Entry Skill Test (DEST) conducted on 02.08.2026 (Sunday) as per the Notification issued vide this office letter No. RE/3-5/LGO/N/2025 dated 11.05.2026 in accordance with the Directorate instructions contained in Letter No.17-08/2018-SPB-I dated 10.05.2019 under Annexure-C, which shall be read with letter No. 17-08/2018-SPB-I (Pt.) dated 10.06.2019 and 17-08/2018-SPB-I dated 20.06.2019, 26.06.2019, 28.06.2019, 11.07.2019, 23.07.2019 letter No.17-08/2018-SPN-I dated 09.09.2021, letter No. 17-08/2018-SPN-I (pt.) dated 21.11.2022, letter No. 17-08/2018-SPN-I dated 19.12.2022, 24.04.2023 and 29.05.2024 and also as per the Recruitment Rules-2022 of PA/SA cadre, notified in GSR 459 (E) dated 17.06.2022, communicated vide Directorate Lr. No. 04-05/2015-SPN-I dated 20.06.2022, Amended vide GSR 21 (E) dated 13.01.2023 and vide GSR 470 (E) dated 01.08.2024 communicated vide Directorate letter No. 04-05/2015-SPN-I (Pt) dated 06.08.2024.

Since the above mentioned LDCE/Competitive Examination (LGO Examination – 2026) is meant for promotion /recruitment of vacancies under Departmental Promotion Quota, no reservation for OBC and EWS categories, is applicable as per the extant rules/guidelines on the subject.

4. In pursuance of Directorate instructions contained in Letter No. 17-08/2018-SPB-I dated 10.05.2019 and other extant rules issued from time to time, the candidates who qualify in Paper-I and DEST separately shall be considered for final selection and their Merit shall be drawn in the order of marks secured in Paper-I since DEST marks are qualifying in nature. Also, as per the Recruitment Rules 2022 of PA/SA cadre, notified in GSR 459 (E) dated 17.06.2022, communicated vide Directorate Lr. 12. Before appointment, it should be ensured that, no disciplinary/vigilance case is pending or contemplated or punishment is current against the selected/allotted candidates. If, any such case exists, such cases should be referred to this office immediately.

13. In case, if it is found subsequently that any of the selected candidate(s) was not eligible to take the examination under the existing rules/instructions on the subject or for any reasons or in case of any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates. Further, in case at any time, it is detected that the selected candidate had applied and appeared the examination with false information/declaration or data, his/her selection will be cancelled without any notice.

14. It may be ensured that no provisionally permitted candidate is given appointment without regularization of his/her candidature. The Divisions/Regions are directed to verify the current status of the candidature of the qualified candidates before issuing the offer of appointment to the promoted post/cadre.

15. The Division/Unit Heads should ensure issue of offer of appointment letters immediately to the successful candidates so that the selected candidates/officials join in their respective offices of posting at the earliest as per extant rules.

16. The successful candidates may be directed to accept and join in the place(s) of posting on promotion or to decline the promotion (format enclosed). The Divisions / Units shall compliance to Circle Office by 31.08.2026 without fail.

17. It is further to intimate that after announcement of the above result, there are no LGO vacancies remained unfilled for the vacancy year 2026 to be offered to Part-(B)/Category-B/GDS candidates, except one (1) UR (PwBD4&5) vacancy, carried forward to next vacancy year i.e. 2027 due to no eligible candidate under PwBD4&5 either in Category A or Category B or GDS candidates.
