Instruction for candidates

1. Candidate shall bring the Hall Permit issued by Head of Division/Unit alongwith Office Identity Card/Aadhaar Card/Voter Identity Card to the examination venue.
2. It is the responsibility of the candidate to get his/her photograph and signature duly attested by the Office-Incharge for appearing in the examination. Candidates failing to comply with this instruction shall not be permitted to appear in the examination.
3. Report time at Exam Venue shall be one hour before the scheduled commencement of the DEST and entry shall be closed 15 minutes before the scheduled commencement of DEST. No candidate shall be permitted to enter the Examination Hall after the prescribed closing time.
4. After entering the examination hall, candidate shall sign the Attendance Sheet in the presence of the Invigilator.
5. Candidate shall occupy only the computer/seat allotted and shall not change his/her allotted seat or computer system without the permission of the Invigilator.
6. Candidate shall not carry any mobile phone, camera, smart watch, calculator, Bluetooth device, earphone/headphone, electronic gadget, paper or any other prohibited material into the examination hall. Any candidate found possessing these items or adopting any unfair means during the DEST shall be liable for appropriate action under the applicable rules.
7. **Candidate shall ensure that the keyboard, mouse and computer system allotted to them are functioning properly before commencing the DEST. In case of any technical problem, the candidate shall immediately inform the Invigilator and shall not attempt to rectify the problem himself/herself. No complaint in this regard shall be entertained after completion of DEST.**
8. Candidate shall carefully read the "Instructions for the Candidates" displayed on the computer screen before commencing the DEST.
9. Candidate shall not start the DEST before the announcement by the Invigilator. The Candidate shall wait for the Invigilator to announce the commencement of the DEST.
10. After the Invigilator announces the commencement of the DEST, candidate shall click the "Start" button to commence the test.
11. After clicking the "Start" button, candidate shall follow the on-screen instructions and shall not close, minimize, refresh or otherwise interfere with the DEST application.
12. Candidate shall not communicate with, seek assistance from, or assist any other candidate during the DEST. Any such act may be treated as use of unfair means/misconduct and may render the candidate liable for appropriate action as per the applicable rules.
13. Candidate shall not leave his allotted seat or the examination hall during the DEST without the permission of the Invigilator.
14. On completion of the DEST, candidate shall follow the instructions displayed on the computer screen and shall wait for further instructions from the Invigilator and not allowed to leave the examination hall unless permitted by the Invigilator.
15. After completion of the DEST, candidate shall carefully verify the particulars printed on the evaluated answer sheet and shall affix their signature in the space provided for "**Signature of the Candidate**".
16. Candidate shall hand over the duly signed evaluated answer sheet to the Invigilator before leaving the examination hall.
17. Candidate shall maintain silence and discipline throughout the examination and shall strictly comply with the instructions of the Invigilator and other examination officials.
18. The decision of the examination authorities/Invigilator regarding conduct of the DEST shall be final and binding on the candidate.
