I am directed to intimate that the Limited Departmental Competitive Examination (LDCE) among eligible Postman/Mail Guard/MTS for promotion to the cadre of Postal Assistant (CO/RO)/ Postal Assistant (PO)/ Sorting Assistant for the vacancy year 2026 (01.01.2026 to 31.12.2026) was held on 28.06.2026 (Sunday), followed by Data Entry Skill Test (DEST) conducted on 16.08.2026 (Sunday) as per the Notification(s) issued vide this office letter No. RE/PA/SA/DP/LDCE/2026 dated 12.05.2026 & 01.06.2026 in accordance with the Directorate instructions contained in Letter No. 17-08/2018-SPB-I dated 10.05.2019 under Annexure-C, which shall be read with letter No. 17-08/2018-SPB-I (Pt.) dated 10.06.2019 and 17-08/2018-SPB-I dated 20.06.2019, 26.06.2019, 28.06.2019, 11.07.2019, 23.07.2019, letter No. 17-08/2018-SPN-I dated 09.09.2021, letter No. 17-08/2018-SPN-I (pt.) dated 21.11.2022, letter No. 17-08/2018-SPN-I dated 19.12.2022, 24.04.2023 and 29.05.2024 and also as per the Recruitment Rules-2022 of PA/SA cadre, notified in GSR 459 (E) dated 17.06.2022, communicated vide Directorate letter No. 04-05/2015-SPN-I dated 20.06.2022, Amended vide GSR 21 (E) dated 13.01.2023 and vide GSR 470 (E) dated 01.08.2024 communicated vide Directorate letter No. 04-05/2015-SPN-I (Pt) dated 06.08.2024.

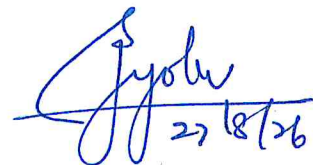

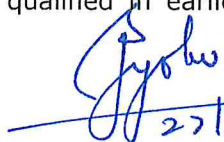
5. In pursuance of Directorate instructions contained in letter No. 17-08/2018-SPB-I dated 10.05.2019, the candidates who qualify in Paper-I and DEST separately shall be considered for final selection and their Merit shall be drawn in the order of marks secured in Paper-I since DEST marks are qualifying in nature. Also, as per the Recruitment Rules 2022 of PA/SA cadre, notified in GSR 459 (E) dated 17.06.2022, communicated vide Directorate letter No. 04-05/2015-SPN-I dated 20.06.2022, and Directorate's instructions in letter No. X-12/6/2021-SPN-II dated 31.12.2021, a single merit list at Circle Level with the successful Category 'A' candidates and selected Category 'B' candidate of the above mentioned LDCE/ Competitive Examination, is prepared and the selected candidates have been allotted to the Divisions/Units as per merit (category wise, i.e., PwBD, UR, SC & ST) vis a vis order of preference exercised by the candidates in respect of Cadre/ Divisions subject to availability of vacancies in the respective Cadre/ Division.

6. Now, the Competent Authority is pleased to announce the result of Limited Departmental Competitive Examination held on 28.06.2026 and DEST conducted on 16.08.2026 among eligible Category 'A' and Category 'B' officials of Postman/Mail Guard/MTS for promotion to the cadre of Postal Assistant (CO/RO)/ Postal Assistant (PO)/ Sorting Assistant for the vacancy years 2026 in the enclosed **Annexure-I**.

7. The inter-se rank/merit of the candidates with equal marks has been decided in accordance with the instructions/ guidelines issued by Directorate vide letter No. 04-08/2019-SPN-I dated 11.12.2020, and the first/top meritorious candidate(s) only has/have been selected and allotted to Division/Unit in the order of his/her/their choice/preference. Consequent to this, if there is change in the merit list, the same may be communicated to this office for issuing correction. The result is also available in the Departmental websites (www.indiapost.gov.in).

8. The information relating to the Names of the candidates, their Roll Numbers and Community have been shown on the basis of information furnished by the Heads of Divisions/Units. The Head of the Divisions/ Units are requested that particulars of Successful candidates, viz. Roll numbers, names, Community and their eligibility to appear in the said examination, are re-checked before issuing offer of appointment. If any, discrepancy has been found the same may be corrected and the matter should be reported to this office.

9. In accordance to instructions contained in Directorate's letter F.No. W-17/10/2023-SPN-I-DOP dated 06.03.2023, candidates who had qualified in earlier LDCE but refused to

accept the offer of promotion will be promoted after completion of one year from the date of refusal of earliest offer of promotion.

10. The selection of the candidate(s) in **Annexure-I** is purely provisional and subject to the fulfilment of required conditions of relevant Recruitment Rules. It may be ensured that no provisional candidate is given appointment without regularization of their candidature. The Divisions/Regions are requested to verify the current status of their candidature of the qualified candidates before promoting the official. **The official/candidate against whom vigilance or disciplinary case is pending/ those undergoing punishment should not be promoted and such cases should be referred back to this office as per Directorate Letter No. X-7/6/2022-SPN-II dated 17.05.2023 as amended vide letter No. X-7/6/2022-SPN-II, 22.09.2023 and 04.03.2024.**
11. **In case, if it is found subsequently that any of the selected candidate(s) was not eligible to take the examination under the existing Rules/Instructions on the subject or for any reasons or in case any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates. Further, in case at any time, it is detected that the selected candidate has applied and appeared the examination with false information/declaration or date, his/her selection will be cancelled without any notice.**
12. The provision of reviewing of results of failed SC/ST candidate(s) has been revisited by the Postal Service Board & decided to discontinue, as communicated vide Postal Directorate Letter No. 4-13-2015-SPB-I dated 08.04.2016.
13. The Division/Unit Heads should ensure issue of offer of appointment letters immediately to the successful candidates so that the selected candidates/officials join in their respective offices of posting at the earliest as per extant rules.
14. The successful candidate may be directed to accept and join in the place(s) of posting on promotion or to decline the promotion. The Divisions/Units shall compliance to Circle Office by **04.09.2026** without fail.
15. It is further to intimate that there are no LGO vacancies remained unfilled for the vacancy year 2026 to be offered to Competitive Examination for recruitment to the cadre of Postal Assistant and Sorting Assistant from Gramin Dak Sevaks (GDSs) after announcement of the above result.
