Sub: Declaration of result pertaining to Limited Departmental Competitive Examination (LDCE) for promotion to the posts of Postman and Mail Guard from eligible Multi-Tasking Staff for the vacancy year 2026 (01.01.2026 to 31.12.2026) held on 12.07.2026 (Sunday) followed by DEST on 30.08.2026.

Ref: Circle Office, Bhubaneswar Notification No. RE/30-22/2026 dated 01.06.2026.

In pursuance of the Postal Directorate letter No. DE-12/3/2026-DE-DOP dated 26.05.2026, notification for conducting Limited Departmental Competitive Examination (LDCE) for promotion to the cadre of Postman and Mail Guard from eligible Multi-Tasking Staff for the vacancy year 2026 (01.01.2026 to 31.12.2026) was issued vide this office letter of even number dated 01.06.2026 for which the written examination for Paper I, II and III was held on 12.07.2026 followed by DEST on 30.08.2026 in accordance with the Directorate instructions contained in Letter No.17-08/2018-SPN-I dated 05.04.2022 and Letter No. 17-08/2018-SPN-I dated 19.12.2022.

2. Final vacancy position for the above LDCE was notified vide this office letter No. RE/30-22/2026 dated 20.08.2026.

3. The Final Answer Keys (Series A, B, C & D) of Paper-I, Paper-II and Paper-III i.r.o the abovementioned examination have already been circulated to all Divisional/Unit Heads vide this office letter of even No. dated 21.08.2026 as well as displayed in Odisha Circle web portal.

4. The qualifying marks for selection to the cadre of Postman/Mail Guard as per Directorate letter No.17-08/2018-SPN-I dated 05.04.2022 is as hereunder.

5. This is a promotional examination and there is no reservation in promotion for OBC and EWS candidates. Hence, the minimum qualifying percentage of UR category will be applicable for them.

6. In pursuance of Directorate instructions contained in Letter No.17-08/2018-SPN-I dated 05.04.2022, selection of candidates will be based on their performance in Paper - I and Paper - II provided a candidate has qualified in both Paper - III and Paper - IV (DEST). Paper -III (Knowledge of local language) and Paper - IV (DEST) are qualifying in nature. Performance in both Paper -I and Paper-II (combined, i.e. total marks secured in Paper -I and Paper - II) will be considered for selection to the posts of Postman/Mail Guard. Accordingly, the result has been prepared taking the marks of Paper-I and Paper-II (Combined) as merit and also in accordance with the procedure prescribed vide Directorate Letter No.17-08/2018-SPN-I dated 18.10.2023 and 31.10.2023. The selected candidates have been allotted to the Divisions/Units as per merit *vis-à-vis* order of preference exercised by the candidates subject to availability of vacancies in the Divisions/Units. This allotment is also subject to change, if any discrepancy found in allotment later on.

7. As per the said Directorate letters dated 18.10.2023 and 31.10.2023, the candidature for selection will be considered only if a post has been opted for subject to fulfilling the eligibility condition and a candidate shall not be considered for a Division/Unit for which preference has not been submitted by him/her.

8. Now, the Competent Authority is pleased to declare the result of Limited Departmental Competitive Examination (LDCE) for promotion to the cadre of Postman/Mail Guard from eligible MTS for which the exam was held on 12.07.2026 followed by DEST on 30.08.2026 as per merit *vis-à-vis* order of preference exercised by the candidates subject

to availability of vacancy in a Division/Unit. The result containing list of successful candidates is enclosed as **Annexure - I**. In case of more than one candidates get clubbed due to scoring equal mark, their inter-se rank/merit has been decided in accordance with the instructions contained in Directorate Letter No.04-08/2019-SPN-I dated 11.12.2020. Consequent to this, if any change is noticed in the merit list, the same may be communicated to this office for necessary correction.

9. Orders/guidelines relating to reservation in promotion to Persons with Benchmark Disabilities issued vide DoPT O.M. No. 36012/1/2020-Estt.(Res.-II) dated 17.05.2022, Directorate letter no. X-20/17/2024-SPN-II dated 13.08.2024 along with DoPT O.M. No. 36035/02/2017-Estt(Res) dated 27.09.2022, and other extant rules/ guidelines issued by Directorate from time to time have been complied with.

10. The selection of candidates in **Annexure-I** is purely provisional and subject to fulfilment of conditions of relevant recruitment rules for promotion to the cadre of Postman/Mail Guard as per Directorate instruction contained vide letter no X-7/6/2022-SPN-II dated 17.05.2023, 22.09.2023 and 04.03.2024.

11. The information relating to vacancies, name of the candidates, Roll Numbers, Date of Birth, Date of entry and categories have been shown on the basis of information/documents furnished by the Head of Region/Division/Unit. **The Divisional /Unit Heads are requested to verify the relevant particulars of the selected candidates at their own level, before issuance of promotion and posting orders. In case, it is subsequently found that any of the selected candidate(s) was not eligible to appear in the examination under the extant rules or instructions on the subject for any other reasons or in case any mistake is found with regard to announcement of result of any candidate for any reason whatsoever, the same may be brought to the notice of Circle Office, Bhubaneswar immediately, so that his/her name could be deleted from the list of successful candidates.**

12. The category of candidates may be rechecked with reference to extant rules. The selection and promotion of the candidates belonging to SC/ST/PwBD category is subject to verification of their category status by the Divisions/Units concerned as per extant instructions on the subject.

13. The candidates of reserved category i.e. SC/ST/PwBD who are shown as qualified on merit and selected against UR vacancies should be adjusted against UR vacancies in the Roster as per the guidelines issued by Department from time to time.

14. Before issuance of promotion and posting order, it should be ensured that no disciplinary/vigilance case is pending or punishment is in force against the successful/selected/allotted candidates. If, any such case exists, the same should be referred to Circle Office, Bhubaneswar immediately.

15. The Divisional/Unit Heads are requested kindly to refer Directorate letter No.W-17/10/2023-SPN-I-DOP dated 06.03.2023, regarding guidelines on "eligibility to appear LDCE after refusal of offer of promotion" before issuance of promotion letter. **Offer of promotion letter shall not be issued to such candidates till completion of one year from the date of refusal of earlier offer of promotion.**

16. **Provisional Candidates:** The Heads of the concerned Divisions/Units are requested to immediately finalize the provisional candidature and such cases should not be kept pending for long time, so that the provisional candidates may not have to wait for the result inordinately. If name of any provisionally permitted candidate is found in the list of selected candidates, the same may be brought to the notice of Circle Office, Bhubaneswar for immediate necessary action. It is informed that the names of the candidates have been arranged in the order of merit cum preference subject to availability of vacancy. It may also be ensured that **no provisional candidate, even if found in the list of selected candidates, shall be given promotion under any circumstances without regularization of his/her candidature.**

17. The following condition may also be incorporated in the promotion order without fail:

"In case, if it is subsequently found that any of the selected candidate(s) was not eligible to appear in the examination under the existing rules/instructions on the subject or for any reasons or in case, any error is found with regard to announcement of result of any candidate for any reasons whatsoever, his/her name will be deleted from the selected list as the case may be."

18. The Divisional/Unit Heads are also requested to ensure issuance of promotion orders to the candidates except the candidates who have not completed one year debarment period from the date of refusal of earlier offer of promotion latest **by 07.09.2026** so that candidates can join their respective offices of posting at the earliest. The guidelines issued vide Directorate's letter No. W-04/2/2020-SPN-I-Part (1) dated 19.10.2020 as well as relevant recruitment rules for promotion/appointment to the cadre of Postman/Mail Guard as amended from time to time may be followed scrupulously while issuing promotion orders.

19. As per the instructions contained in the Directorate letter No. 17-08/2018-SPN-I dated 18.10.2023, the Heads of Divisions/Units should ensure that promotion orders will be issued in case of the successful candidates clearly indicating that if the official does not join the promotional post within Seven (07) days it will be deemed to have been refused. Controlling officer shall immediately relieve the official to join promotional post. Official on leave may be allowed to join even after seven days if they communicate in writing to accept the promotion and in that case the official will be allowed to join after expiry of approved leave period (*Controlling officers are advised to contact such*

successful candidates who are on leave for obtaining their consent to join promotional post in writing. Similarly, candidates who do not wish to join promotional posts may be encouraged to communicate the same in writing). **Therefore, all the Divisional Heads are requested to submit the refusals (if any) of the selected candidates by 14.09.2026 so that the selection of next meritorious candidates may be done in time.**

20. No request for revision / change of allotment of Cadre/Division/Unit will be entertained in any circumstances.

21. The results and contents of this memo may be brought to the notice of all concerned.
