Sub: Declaration of result in r/o Limited Departmental Competitive Examination for promotion to the cadre of Postman/Mail Guard from eligible MTS for the vacancy year 2026, held on 12.07.2026 & DEST held on 07.09.2026.

I am directed to forward herewith the result of Limited Departmental Competitive Examination (LDCE) for promotion to the cadre of Postman/ Mail Guard from eligible Multi-Tasking Staff for the vacancy year 2026 (01.01.2026 to 31.12.2026) held on 12.07.2026 & DEST held on 07.09.2026, as Annexure - I.

2. Division-wise vacancies of Postman/Mail Guard for the year 2026 has already been circulated vide this office letter no. R&E/77-7/2026-kw dated 13.08.2026. The summary of filled and unfilled vacancies is enclosed as Annexure - II.

3. One backlog vacancy (LV) notified under PwBD category in Shimla Division remains unfilled due to non-availability of qualified candidate. Similarly, three posts notified under ST category (one each in Chamba, Mandi and Shimla Division) remain unfilled due to non-availability of candidates belonging to said category. All the unfilled vacancies will now be added to the number of vacancies under 50% quota to be filled by Direct Recruitment on the basis of Competitive Examination limited to GDS, as per Recruitment Rules.

4. The result has been prepared as per guidelines issued by Directorate letter no. 17-08/2018-SPN-I dated 05.04.2022, 19.12.2022 & 10.07.2024 and the allotment of Divisions/Units to selected candidates has been made as per instructions contained in Directorate letter No. 17-08/2018-SPN-I dated 18.10.2023 & 31.10.2023. This allotment is also subject to change, if any discrepancy found in allotment later on.

5. The *inter se Rank / merit* of candidates has been decided as per Directorate's letter No.04-08/2019-SPN-I dated 11.12.2020. The result is also available in the Departmental website (www.indiapost.gov.in).

6. The information relating to the name of candidates, their roll numbers, categories, etc. have been shown on the basis of information furnished by the Divisions/Units. In case, there are any mistakes in the details of candidates, the same may be intimated to this office for necessary action. In case, if it is found subsequently that any of the promoted/ selected candidate was not eligible for the examination/selection under the existing rules/ instructions on the subject or for any other reasons or in case any mistake is found with regard to declaration of result of any candidate for any reason whatsoever, his/her name

will be deleted from the list of successful candidates, as the case may be. This result is also subject to change in the merit list of successful candidates due to any unforeseen reason in accordance with the existing rules and instructions on the subject.

7. The result of all successful candidates is subject to fulfillment of eligibility criteria to be decided by the concerned Divisional/Unit Head and vigilance status of the candidates. The officials/candidates against whom vigilance or disciplinary case is pending/ those undergoing punishment should not be promoted and such cases should be referred back to this office as per directions of Directorate issued from time to time.

8. Final Answer Keys of above examination have already been uploaded in the Departmental website i.e. www.indiapost.gov.in on 12.08.2026.

9. All the Divisional Heads/Appointing Authorities are requested to cause issuance of promotion/appointment orders immediately. The appointing authorities are also requested to carry out all the required pre-appointment formalities as provided in relevant rules and instructions issued from time to time.

10. While checking the Community Certificates (SC/ST) vis-à-vis with educational certificate, discrepancies in surnames in the names of applicant and, in some cases, in the names of their father, have been noticed. All Divisions/Units are, therefore, requested to ensure proper reconciliation and verification of such discrepancies before taking further action.

11. Divisional/Unit Heads are requested to take immediate necessary action for joining of newly selected candidates as per extant provisions. The Divisional/Unit Heads are requested not to send separate letter of carrying out joining process/appointment letters to Circle Office. The joining process should be completed on or before **18.09.2026**.

12. Divisional /Unit Heads concerned are directed to submit the unwillingness/refusal of the candidate, if any, by 18.09.2026 positively. If any Division/Unit especially which the candidate is presently working failed to submit the refusal within stipulated time to Circle Office, they will be held responsible for that.

13. Request for revised allotment of any candidate will not be entertained.

All Divisional/Unit heads are requested to display the above result on the office notice board.
