I am aware that:

1. The LDCE results are declared based on the Department of Posts, Postman and Mail Guard Recruitment Rules, 2018 and as amended from time to time, SOP vide letter No. A-34012/02/22-DE dated 11.08.2022, model notification issued by Directorate vide letter No.DE-12/03/2026-DE -DOP dated 26-05-2026 and Notification issued vide this office Letter(s) No. R&E/1-7/2026 dated 01-06-2026 AND R&E/2-19/2026 dated 01-06-2026 & relevant rules and instructions issued by the Department from time to time.
2. Candidates will be allotted to the Divisions/Units as per merit in Paper I+ Paper II [Category wise, UR, SC & ST) vis-a vis order of preference exercised by the candidates subject to availability of vacancies in the respective Cadre & Division/Unit on their turn of allotment. Directorate's Instructions issued vide letters No.17-08/2018-SPN-I dated 5.4.2022, 19.12.2022; 18.10.2023 & 31.10.2023 are taken into account for selection of candidates as per Circle Merit.
3. In pursuance of Directorate instructions contained in Letter No.17-08/2018-SPN-I dated 05.04.2022, the candidates who qualified in Paper-I, Paper-II, Paper-III and Paper- IV (DEST) separately shall be considered for final selection and the Merit List will be prepared only on the basis of total (combined) marks secured by the candidate in Paper I & Paper II, since Paper-III and Paper-IV (DEST) are qualifying in nature and will not count for deciding the merit in case of tie etc.
4. In case of deciding of inter-se rank/merit in case of more than one candidate scoring equal marks, instructions contained in Directorate Letter No.04-08/2019-SPN-I dated 11.12.2020 will be adopted.
5. **Candidate who have come in Merit in respective category, but could not be considered for Division/unit allotment due to limited options/ order of preference exercised by the candidates since the vacancies have already be allotted to more meritorious candidates above them on his/her turn of allotment.**
6. Candidates who have been allotted Division / Unit and joined will not be eligible for re-consideration for re-allotment to other Divisions / Units ***[which were their top preferences and could not be allotted due to non-availability of vacancies on their turn of allotment since it was already allotted to meritorious candidates above them]*** in which vacancies may arise if any due to declination and these declined vacancies will allotted to the next meritorious candidates below me in the list, even though they rank junior to me in ranking.
7.
