No. RE/LDCE/PM&MG/2026/Results Dated at Hyderabad - 500 001, the 11.09.2026

The Competent Authority is pleased to declare the results of the Limited Departmental Competitive Examination (LDCE) for promotion to the posts of Postman and Mail Guard from eligible MTS officials for the vacancy year 2026 (01.01.2026 to 31.12.2026), held on 12.07.2026 (Sunday) and DEST conducted on 06.09.2026 (Sunday).

2. The minimum qualifying criteria prescribed by Directorate in Annexure-"I" of letter no: 17-08/2018-SPN-I dated 05.04.2022 & 19.12.2022 for LDCE/CE for Postman/ Mail Guard and in accordance with the Standard Operating Procedure issued by Directorate vide letter no. A-34012/02/2022-DE dated 11.08.2022, the minimum qualifying marks are as follows.

*Due to deletion of 5 questions in Paper-I, the maximum marks of Paper-I is revised as 90 marks and that of Paper-I & II as 140 marks and accordingly qualifying marks are fixed as above in accordance with Directorate letter no. A-34012/02/2022-DE dated 21.09.2023.

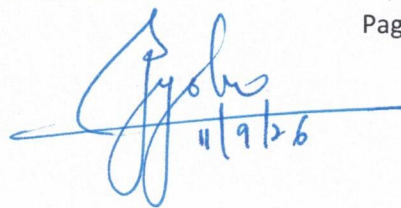
3. LDCE is a promotional examination and no reservation in promotion for OBC and EWS candidates. Hence, the minimum qualifying percentage of UR category will be applicable for them.

4. The PM/MG vacancies notified in notification addendum no. RE/LDCE/PM&MG/2026 dated 28.08.2026 may be treated as final.

5. The LDCE results are declared based on the Department of Posts, Postman and Mail Guard Recruitment Rules, 2018 and as amended from time to time, SOP vide letter no. A-34012/02/2022-DE dated 11.08.2022, model notification issued by Directorate vide letter No. DE-12/3/2026-DE-DOP dated 26.05.2026 and Notification issued vide this office letter No.RE/LDCE/PM&MG/2026 dated 01.06.2026.

6. In pursuance to instructions contained in Directorate letter No.17-08/2018-SPN-I dated 18.10.2023 & 31.10.2023, No. 02-01/2018-SPB-I dated 07.02.2019 and Department of Posts, Postman and Mail Guard Recruitment Rules, 2018 & Department of Posts, Postman and Mail Guard Recruitment Rules (Amendment), 2023 selection of candidates through examination has been done by preparing a single merit list at Circle Level. The selected candidates have been allotted to the Divisions/Units as per merit (Category wise, UR, SC & ST, PwBD) vis-a-vis order of preference exercised by the candidates subject to availability of vacancies in the respective Cadre & Division / Unit.

7. The results containing list of the successful MTS candidates of LDCE for promotion to the post of Postman / Mail Guard for the vacancy year 2026 held on 12.07.2026 and DEST conducted on 06.09.2026 are arranged in the Circle-wise merit order as shown in **Annexure-I**. The inter se rank/merit of candidates has been decided as per Directorate's letter No. 04-08/2019-SPN-I dated 11.12.2020. Consequent to this, if there is change in the merit list, the same may be communicated to this office for issuing correction. The result is also available in the Departmental website www.indiapost.gov.in.

9. No re-allotment requests for change of Divisions / Units will be entertained or considered in respect of candidates in this list under any circumstances.

10. Candidates in this merit list who have joined the Division / Unit allotted to them will not be eligible for re-consideration for re-allotment to other Divisions / Units (which were their top preferences and could not be allotted due to non-availability of vacancies on their turn) in which vacancies may arise due to declination and these declination vacancies will be allotted to the next meritorious candidates.

11. The information relating to names of the candidates, their roll numbers and categories have been shown on the basis of information furnished by the Heads of Region/Division/Unit. In case there are any mistakes in the details of candidate(s), the same may be intimated to this office for necessary action. In case, if it is found subsequently that any of the selected candidate(s) was /were not eligible to take the examination under the existing rules/instructions on the subject or for any reasons or in case any mistake is found with regard to announcement of results of any candidate for any reason whatsoever his/her name will be deleted from the list of successful candidates, as the case may be.

12. In respect of PwBD candidates, instructions issued from time to time should be followed. The Division concerned should verify category of physically challenged person in which he/she sought relaxation from appearing DEST and obtain the medical certificates issued by the competent authority from the candidates concerned as per relevant instructions and GOI orders.

13. The selection of the candidates from reserved category viz., SC/ST/PwBD is subject to verification of their certificates by the Divisions/Units concerned, as per extant instructions on the subject.

14. The candidates of reserved category i.e SC/ST/PwBD who are selected against UR vacancies should be adjusted under UR vacancies in the roster.

15. In accordance with the instructions contained in Directorate's letter No. W-17/10/2023-SPN-I-DOP dated 06.03.2023, the candidates who were declared successful through LDCE for promotion, but declined their promotion already and have again been declared successful through LDCE for promotion to Postman/Mail Guard cadre for vacancy year 2026 now should be promoted only after completion of one year from the date of last declination.

16. The selection of the candidates is purely provisional subject to the fulfillment of required conditions of relevant Recruitment Rules. It may be ensured that no provisional candidate is given appointment without regularization of their candidature. The Divisions/Regions are requested to verify the current status of the candidature of the qualified candidates before issue of appointment order to the official. The official/candidate against whom vigilance or disciplinary case is pending/those undergoing punishment should not be promoted and such cases should be referred back to this office as per Directorate's letter No. X-7/6/2022-SPN-II dated 17.05.2023 as amended vide letter No.X-7/6/2022-SPN-II dated 22.09.2023 and 04.03.2024.

17. Name, Roll Number, Category and other details like DOB of the allotted candidates are based on the information furnished by the Regions/Divisions/Units. Hence, it is requested to check all information of the allotted candidates with the available records thoroughly before issuing order of appointment/ order of relief.

18. The following condition may also be incorporated in the selection memo without fail:

"In case, if it is found subsequently that any of the selected candidate(s) was not eligible to take the examination under the existing rules/instructions on the subject or for any reasons or in case, any error is found with regard to announcement of results of any candidate for any reasons whatsoever, his/her name will be deleted from the select list, as the case may be. This result is subject to orders in any case pending before any court of law and is also subject to change in the merit list of successful candidates due to any unforeseen reason in accordance with the existing rules and instructions on the subject"

19. All the Heads of Divisions/Units of selected candidates are instructed to take immediate necessary action for joining of newly selected candidates as per extant provisions.

20. The Divisional / Unit Heads are requested to issue appointment orders to the successful candidates immediately, clearly indicating that if the official does not join within Seven (07) days it will be deemed to have been refused. Official on leave may be allowed to join even after seven days if he/she communicates in writing to accept the appointment and in that case the official will be allowed to join after expiry of approved leave period. Controlling officers are advised to contact such successful candidates who are on leave for obtaining their consent to join after expiry of leave in writing. Similarly, candidates who do not wish to join may be encouraged to communicate the same in writing. The Regional / Divisional Heads are requested to obtain the declaration of those candidates who are declining the selection as Postman / Mail Guard and submit report to Circle Office on the same day.

21. A consolidated joining report of selected candidates to be submitted to this office by Regional Offices by 21.09.2026.

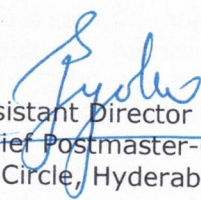

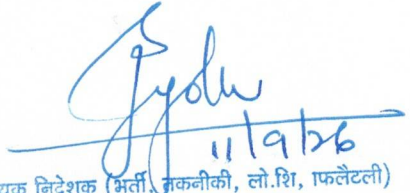
