

Memo No. STC/1-6/MM/2022 dated at Chennai 600 002 the 24.09.2026

In pursuance of the orders contained in Directorate Order in F.No. R-09/15/2026-SPG-II –DoP dated 10.09.2026 and CO memo no. STC/1-6/TRF/2026 dated 22.09.2026, the Competent Authority is hereby conveyed for promotion and positing of the following Inspector Line officials to Postal Service Group-B cadre on regular basis in Level-9 of Pay Matrix (7th CPC) (Rs.53,100/- to 1,67,800/-) with effect from the date of assumption of charge of the post and until further orders.

2. GENERAL CONDITIONS:

- (i). The promotion will be effective from the date of assumption of charge of the post of PS Group 'B' Officer on regular basis.
- (ii). Request for reallotment of Region will not be considered unless Officers/Officials joins in the promotional post.
- (iii). All terms and conditions as mentioned in Directorate Order no.R-09/15/2026-SPG-II –DoP dated 10.09.2026 and CO memo no. STC/1-6/TRF/2026 dated 22.09.2026 will remain same.
- (iv). It is the responsibility of the Officer/Officials to send a copy of the charge report through the Head of Circle/Director, PTC concerned on assumption of charge of the promoted post to Assistant Director (SPG-II), Postal Directorate, New Delhi- 110001 for information.
- (v) Chennai city Region is requested to relieve the Officers/Officials immediately to enable him to join on his promotional post.
- (vi). In case of Officer/Official who is not willing to accept his promotion, his declination letter in writing duly forwarded by the Divisional office should reach this Office within 30 days of issue of this order. Non-assumption of charge within 30 days, without valid reason, will be treated as deemed declination of Promotion.

3. VIGILANCE / DISCIPLINARY CASE - IF ANY:

(a) If there is any vigilance/disciplinary case as referred to in DoP&T O.M.No.22011/2/86-Estt(A) dated 12.01.1988 issued by DoP&T circulated vide Directorate Memo No.25-19/88-SPG dated 04.05.1988 (subsequently) revised vide DoP&T memo No.22022/4/91-Estt(A) dated 14.09.1992 circulated vide Directorate memo No.25-19/88-SPG dated 13.10.1992 is pending against the Officer/Official, **The Officer/Official should not be relieved for posting without obtaining specific orders from Directorate.** The promotion of the official should not be withheld on the mere ground that disciplinary action is contemplated, expect the circumstances when the officer/Official is under suspension or a charge sheet has been issued to the official or prosecution for a criminal charge is pending against the Officer/Official. The Officer/Official against whom any punishment is current except censure and recovery of money, they should not be promoted before expiry of currency of punishment. **An intimation report in this respect may be submitted immediately to this Office.**

(b) The instructions issued by Personnel Division (SPN-II) Section vide its letter no. SPN X-7/6/2022-SPN-II dated 17.05.2023 will be ensured by the Division.

4. PROBATION PERIOD:

The Officer/Official who has been promoted to the Postal Service Group 'B' will be on probation for two years and then their suitability to hold this post will be adjudged on completion of probation. If any Officer/Official proceeds on leave for a period exceeding 30 days during this period, the probation will be extended depending upon the period of leave.

5. TRAINING:

The Officer/Official will be directly promoted to Postal Service Group 'B' cadre without any training for the present. However, they will have to undergo prescribed training as and when notified by Director, Rafi Ahmed Kidwai National Postal Academy, Ghaziabad.

6. OPTION FOR FIXATION OF PAY:

The Officer/Official wishing to give option for choosing date for fixation of pay under FR-22[I](a)(1) should do so within one month from the date of assumption of charge on promotion.
