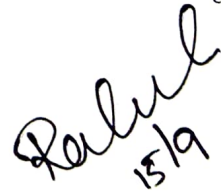
- In strict compliance with the principles laid down by the Hon'ble Supreme Court in Shri K Meghachandra Singh judgment, the seniority of all officers shall be reckoned strictly from the date on which they are officially borne in the cadre upon their actual physical assumption of charge.
- No retrospective seniority, notional promotion or back dated financial benefit shall be admissible prior to the date of actual entry into the cadre, as an employee cannot claim seniority from a date prior to their actual induction into the cadre.

c) This re-allocation of vacancy year carries no element of notional pay escalation or retrospective pay fixation, stepping up of pay or financial entitlement accrue from the revised vacancy year. Pay remains fixed as per actual physical assumption of charge of the promoted post.

(II) General conditions in respect of newly promoted PS Group B officers allotted to Kerala as per C of Directorate letter No. R-09/15/2026-SPG-II-DoP dated 10.09.2026

- a) Inter-se seniority of the selected officers will be fixed by Personnel Division in due course.
- b) Re-allotment requests, if any, shall not be entertained before completion of tenure as envisaged in the Directorate letter No.9-23/2014-SPG dated 25.02.2020.
- c) It is responsibility of the officer to send a copy of the charge report through the Head of Circle/Director, PTC concerned on assumption of charge on the promoted post to SPG-II Section, Postal Directorate, New Delhi-110001 for information.
- d) Parent Postal Circles are requested to relieve the concerned officials and direct them to join their new assignments immediately on receipt of posting orders from the concerned Regions.
- e) In case officer(s) who is not willing to accept his/her promotion, his/her declination letter in writing duly forwarded by the Circle Office should reach Directorate within 30 days of issue of Directorate order No. R-09/15/2026-SPG-II-DoP dated 10.09.2026. Non assumption of charge within 30 days without valid reason will be treated as deemed declination of promotion.
- f) The officials who have been promoted to Postal Service Group B will be on probation for two years and then their suitability to hold the post will be adjudged on completion of probation. If any official proceeds on leave for a period exceeding 30 days during this period, the probation will be extended depending upon the period of leave.
- g) The official will be directly promoted to Postal Service Group B cadre without any training for the present. However, they will have to undergo prescribed training as and when notified by the Director, Rafi Ahmed Kidwai National Postal Academy, Ghaziabad.
- h) The officers wishing to give option for choosing date for fixation of pay under FR-22(I)(a)(I) should do so within one month from the date of assumption of charge on promotion.
